## **Important - Childcare SASS part two**

CSSIW will be emailing all childcare providers regarding the second part of the SASS, to let them know it will be happening in May. This will be the first communication to give a date for when SASS part two will be happening.

SASS part two will involve the Quality of Care Review and a number of other questions, all using CSSIW Online.

If CSSIW have your email address, you'll receive an email from them. If not, you'll receive a hard copy by post.

#### **Advice for providers**

Between now and May, providers can start ensuring that their Statement of Purpose is up-to-date.

If you already have a CSSIW Online account you can log in and check your contact details are correct. You can also view your submitted SASS part one.

If you didn't submit or only partially completed SASS part one, you will need to complete it at the same time as SASS part two, in May. **You cannot do anything online now.** CSSIW will not be able to accept late SASS part one before May.

#### Website

CSSIW will be posting a news item on their website which will closely follow the email that providers will receive. The website will be updated over the next few months to ensure that there's relevant information on there for providers. It will be kept up-to-date on the latest developments.

#### Help

When SASS part two goes live in May, CSSIW be providing technical support, and umbrella organisations will be once again providing support to providers, helping you to complete the form and encouraging you to use CSSIW Online.

Most providers completed SASS part one on time, but for those who didn't, the inspectorate wrote to them to advise them that they'll *still need to complete SASS part one* this spring, along with SASS part two.

CSSIW will be issuing guidance on SASS part two in February and will be contacting all providers ahead of SASS part two going live to remind them about the process and what action they need to take to meet their legal requirements.

## National Minimum Wage and National Living Wage

National Minimum Wage The National Minimum Wage (NMW) is the minimum pay per hour most workers are entitled to by law. The rate will depend on a worker's age and if they are an apprentice.

The National Living Wage The Government's National Living Wage introduced on 1 April 2016 for all working people aged 25 and over, and is currently set at £7.20 per hour. In April 2017 it will go up to £7.50. The current National Minimum Wage for those under the age of 25 still applies. The rate will change every April. The rates from 1 April 2017 will be:

- £7.50 per hour 25 yrs old and over
- £7.05 per hour 21-24 yrs old
- £5.60 per hour 18-20 yrs old
- £4.05 per hour 16-17 yrs old
